**Location:** Asphalt Green Aqua Center, 1750 York Ave. NYC

**Facility:** 8 lane, all deep water 25 yard pool, plus two lanes designated for continuous warm-up. Electronic timing and scoreboard display with integrated computer results software.

**Eligibility:** Open to all members of USMS or other FINA affiliated NGB who are age 19 or older. Age group of a swimmer is determined by the age on April 3, 2005. Photocopy of 2005 USMS card must be attached.

**Entry Notes:** Maximum of 4 individual events per session. Entries will be accepted on a first-come, first-served basis and limited to finish by the designated time. Surplus entries will be returned. Enter Short Course Yards times for all events. Fill out all required personal information on entry. All relay categories are being offered; men, women, mixed.

**Seeding:** Heats will be swum slow to fast. Individual events 200 and shorter will be pre-seeded; 400 and longer require check-in and will be deck seeded. Relay events will be entered and seeded at the meet.

**Awards:** 1<sup>st</sup>, 2<sup>nd</sup>, & 3<sup>rd</sup> place for each USMS age group in all events

**Entry Deadline:** All entries must be received by Tuesday, 03/29/2005.

The following must be enclosed with each entry:

- Completely filled out entry sheet, **including signed waiver**.
- Copy of 2005 USMS registration card (or equivalent).
- Check payable to **Asphalt Green** or signed credit card info.

**Spectators:** Only swimmers, coaches, officials, and timers will be allowed on deck. All others at the meet must stay in the designated spectator area on the 2<sup>nd</sup> floor of Asphalt Green. **People wishing to volunteer to serve as a timer should check-in at the table on the pool deck. Their help is greatly appreciated.** (No street shoes on the pool deck.)

**Facility Note:** • **No Smoking is Allowed in the Building** • **No Food or Glass Bottles on the Pool Deck** • Swimmers are expected to police and maintain their areas on the pool deck. Swimmers and spectators are restricted to the 1<sup>st</sup> and 2<sup>nd</sup> floors of the AquaCenter and are not authorized in any other areas of the Asphalt Green campus. Offenders will be ejected from the facility.

**Parking:** • Street parking is available according to NYC regulations. • **\$10 for up to 5 hours or \$12 for up to 8 hours is available only at *The Brittainy* – 1775 York Ave.** Entrance is on 92<sup>nd</sup> near York Ave on North (left) side. You must get your parking ticket stamped by the Front Desk Receptionist at the entrance of Asphalt Green. • Additional parking garages are available in the local area; however they do not offer discounted rates.
